Zirkle Merit Scholarship Form

Grant Requirements for the 2026-2027 School Year

This scholarship recognizes academic high achievers enrolling in the 9th grade at Shenandoah Valley Academy

Eligibility

Award recipients will be selected and approved by the Student Scholarship Committee according to the following criteria:

1. Zirkle Merit Scholarships are only offered to new 9th grade students who enroll at SVA.
2. The scholarships continue through the 10th, 11th, and 12th grades depending on academic performance.
3. The maximum total for all merit scholarships (Academic, Leadership, Music, Athletic, etc.) per student per year is \$5,000 for boarding students and \$2,500 for day students.
4. Eligible scholarship candidates will have earned a complete composite score in the 80th percentile or higher on an approved nationally-normed standardized test (mapGROWTH Achievement Percentile Score, ITBS, TAP or Open Edition High School Placement test).
5. Scholarships will be awarded based on the following table:

New students eligible for the program (based on complete composite standardized test scores)	Annual scholarship award for new students	
	Boarding	Day
80-84 th percentile	\$2,000	\$1,000
85-89 th percentile	\$3,000	\$1,500
90-94 th percentile	\$4,000	\$2,000
95 th + percentile	\$5,000	\$2,500

6. Grade reports must demonstrate a commitment to academic excellence.

Payout and Renewal Process

1. Scholarships are grants for one year. Grants for returning students are payable based upon Student Scholarship Committee approval of students who have met all the program criteria including:
 - a. A behavior record demonstrating good standing with an attendance grade of “B” or better.
 - b. An overall GPA of 3.4 or better in the core courses (the cumulative core UGPA - English, Mathematics, Science, Social Studies and Religion).
 - c. Completion of a minimum of 120 work hours in the SVA work/study program.
2. Scholarship awards for each succeeding year will be based on the cumulative GPA earned in core subjects. Students will receive the annual award up to a maximum of \$5,000 in any given year as indicated in the table below:

Scholarships for next academic year (based on overall core subject GPA in the previous year)	Maximum scholarship award for 10 th , 11 th , and 12 th grade students	
	Boarding	Day
80-84 th percentile	\$2,000	\$1,000
85-89 th percentile	\$3,000	\$1,500
90-94 th percentile	\$4,000	\$2,000
95 th + percentile	\$5,000	\$2,500

3. If a scholarship student withdraws during the school year for any reason, the scholarship award for that year will be rescinded.
4. Under this program, the total merit (Academic, Leadership, Music, Athletic, etc.) scholarships awarded per student for one year cannot exceed \$5,000 for boarding students and \$2,500 for day students.

3. The student is required to work 120 hours during the school year.
4. If a Zirkle recipient withdraws during the school year for any reason, the scholarship award for that year will be rescinded.
5. The maximum total for all merit scholarships (Academic, Leadership, Music, Athletic, etc.) per student per year is \$5,000 for boarding students and \$2,500 for day students.
